Please read the attached notes carefully; these will outline copyright permissions as set out in the Data Protection Act.

Copyright material and permissions

Unless agreed otherwise, it is the **author's responsibility** to obtain written permissions for extensive quotations, epigraphs, figures, tables or any other material, whether published or unpublished, that are in copyright and do not fall under the rules of 'fair dealing'. *citation or motto at the beginning of an article, book or book section.

If the author has not obtained all necessary copyright permissions by the time the manuscript is delivered to the EoLFHS Editorial Board, it is likely that the publication date will be delayed.

Articles from 'Cockney Ancestor may later be re-published on the EoLFHS website, so please ensure in obtaining the copyright permission to publish that this is also acceptable to the copyright holders. Material on the web is still covered by copyright.

Authors may need to review their manuscripts to eliminate any expensive material and omit any other material for which, for whatever reason, it has not been possible to obtain permission. Where family material is very old the author may feel publication without copyright carries little risk of a copyright challenge and that the author is willing to carry this risk. A statement to this effect should be attached.

Copyright and fair dealing

In the UK and throughout the EU, material is out of copyright at the end of the calendar year 70 years after the death of the author. Fair dealing is not clearly defined, but generally allows, for the purpose of criticism or review, the use of:

- a single prose extract of up to 400 words from a single source;
- a series of prose extracts of up to 800 words, each of which must be no longer than 300 words, from a single source;
- up to 40 lines of verse, provided that they don't comprise more than a quarter of the entire poem.

Copyright permission must be obtained for any other extracts or reproductions of creative works, including:

- short quotations used as epigraphs, regardless of length – these do require copyright permission and must be accompanied by a full reference; quotations from quotations websites and unreferenced quotes of any kind are not acceptable;
- poetry and literary works;
- newspaper and magazine articles;
- drama and film scripts;
- song lyrics;
- photographs or illustrations that are not taken or drawn by the author, or in which people other than the author appears;**
- tables, figures and lists;

- single extracts of more than 400 words from academic works, or several extracts from a single academic work totalling more than 800 words.

** where a group photograph was taken to record an event, and it was clear those pictured were aware of the likelihood that it will be reproduced repeatedly then it is not essential to contact all the subjects. However, permission from the photographer for publication may still be necessary.

Requesting permission

Authors need to obtain permission for non-exclusive world English print and electronic use. Authors will need to send to the person or organisation who holds the copyright: a covering letter and a copy of the material to be reproduced, along with the permission form and stamped addressed envelope for its completion and return. An email request form should be printed, signed and returned by the copyright holder to the author by snail-mail unless they use a recognised digital signature.

Check the copyright page and acknowledgements page of the book from which you are taking the extract; in the case of tables or figures, check the caption too.

For written works the copyright holder could be the publisher, the author's solicitor, a family member or estate holder. Particularly for literary works, there may be separate UK and US/Rest of World rights holders, and you will need to obtain permission from all of them.

For photocopied material obtained from Public Record Offices or Archives there may be a stamp giving further details of copyright/reproduction requirements. Researchers should also check a copy of the application form for that initial copying or the application form for use of the archive where the requirements for reproduction of material other than for private study will have been described.

For photographs, permission from the photographer will be needed and from any people pictured, or their next of kin (see above). For works of art, you will need to obtain permission from the artist, a picture library or museum.
